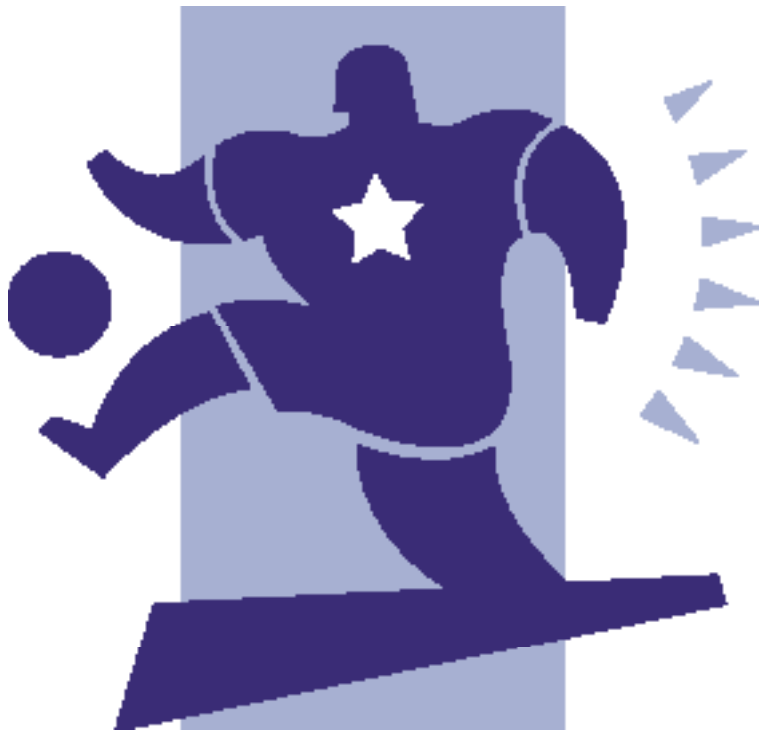

\* *NR: Stands for non-resident. Each player not living in the PH District must pay an additional fee of \$5. A maximum of 7 non-residents will be charged.*
