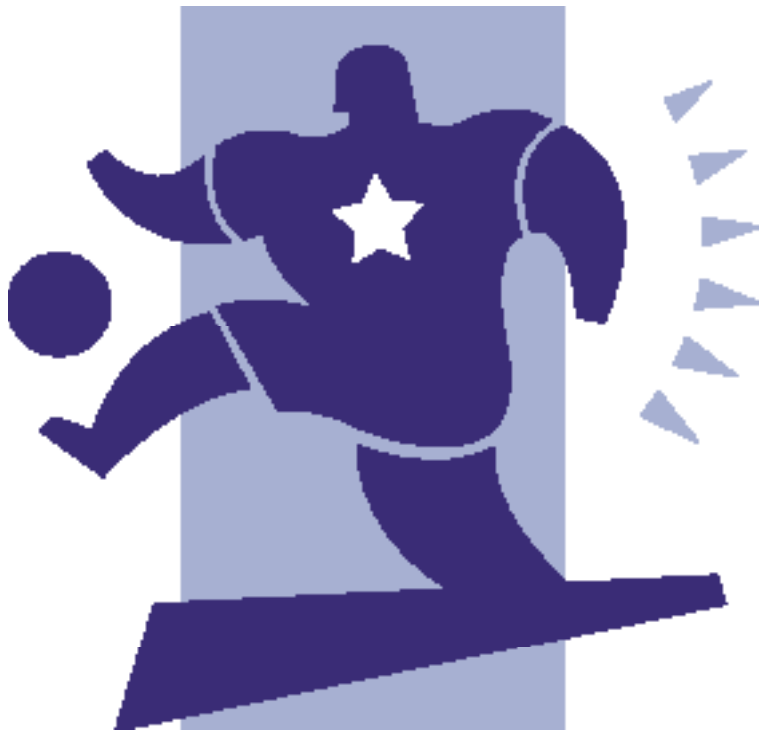

* *NR: Stands for non-resident. Each player not living in the PH District must pay an additional fee of \$5. A maximum of 7 non-residents will be charged.*

The season will begin on May 14 and will run through June.

A percentage of your league and non-resident fees will be designated for improvements to comply with the American Disability Act, and to pay for the increased electrical rates for the field lights & more.
