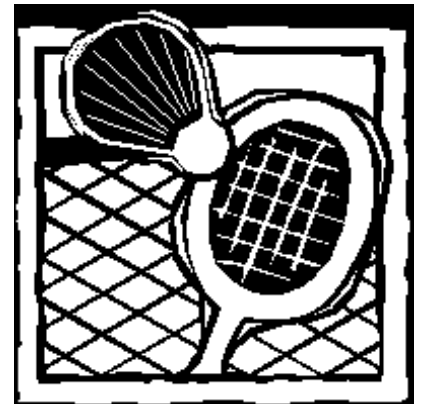

Welcome to Pleasant Hill Recreation & Park District 2010 Summer Adult Kickball League. This packet contains important information concerning our league. Please be sure to read all of it, so you will understand our registration process, roster form, league rules, league fees and the length of our season. A checklist is provided in this packet to help the Team Representatives turn in a complete registration packet.

The Summer Season will consist of a six (6) game schedule followed by single elimination play-offs. All games will be officiated by one umpire.

* *NR= Non-Resident. Each player not living in the PH District must pay an additional fee of \$5. A maximum of 7 non-residents will be charged.*

The season will begin on July 16 and will run through September.

A percentage of your league and non-resident fees will be designated for improvements to comply with the American Disability Act, and to pay for the increased electrical rates for the field lights & more.

PHILOSOPHY

One of the goals of the Pleasant Hill Recreation & Park District is to provide recreational opportunities for people of all ages. The Adult Kickball League provides the community with an opportunity to participate in an organized sport activity. The leagues are organized for competitive play but the overall goal is enjoyable participation for all. The District is not offering professional leagues. **The main emphasis of the league is the recreational elements including the fun, enjoyment, good sportsmanship, and friendships that are developed.**

Registration will not be accepted without payment. Priority for filling the spots in the league will be on a first received, first placed basis. ALL teams are encouraged to turn their packets in well before their registration deadline. *There are no refunds once a team is placed in a league. If league(s) are cancelled money will be refunded.*

ROSTERS:

Be sure all information is completed on the roster including each players name, address, phone number, drivers license number and signature. **If information is left out or your check bounces, the packet will be declared incomplete.**

Roster additions and deletions must be made before 5:00 pm, Monday through Friday, prior to your game. This must be done at the Administrative Office or by mail with the League's "Add/Drop Form" (umpires and scorekeepers will not handle any additions or deletions). An added player may not use a dropped player's non-resident fee after **July 16**. Teams may carry a minimum of ten (10) and a maximum of twenty (20) players on their roster.

KICKBALL RULES:

All rules, regulations, schedules and information will be discussed and handed out in a pamphlet at the team representatives meeting to be held **Tuesday, July 6, 6:00 pm, at Pleasant Hill Recreation & Park District Administration Office at 147 Gregory Lane, Pleasant Hill.** **All Team Representatives are Required to Attend the Meeting.**

LEAGUE INFORMATION:

The league is TENTATIVELY scheduled to play on Friday nights.

NOTE: Teams may play on other nights not designated as above due to field availability, play-offs, makeup games, and/or size of a particular league. Remember, Pleasant Hill Recreation & Park District reserves the right to make FINAL JUDGMENT on TEAM PLACEMENT and does not guarantee placement of any team.

League fees cover: The specified number of games, umpire (1), scorekeeper (1), Kickballs, league awards, field maintenance and lighting.
