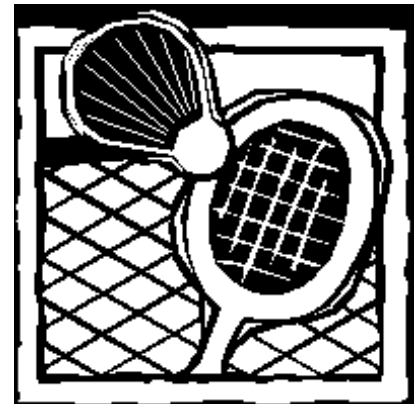

RE: ADULT SOCCER PROGRAM — 2010 Fall Season

The Pleasant Hill Recreation & Park District is announcing its Fall season of our "5-on-5" Adult Soccer League. The games are played on smaller fields with smaller goals and no goalies. Smaller teams allow more games and players per hour to use the field, and make it easier to put together teams. It also allows all players to touch the ball more often. **Due to the popularity of our adult programs, we strongly encourage you to register early.**

PHILOSOPHY:

One of the goals of the Pleasant Hill Recreation & Park District is to provide recreational opportunities for people of all ages. The Adult Soccer League provides the community with an opportunity to participate in an organized sports activity. The leagues are set-up for competitive play but the overall goal is enjoyable participation for all. The District is not offering professional leagues. **The main emphasis of the league is the recreational elements including the fun, enjoyment, good sportsmanship, and friendships that are developed.**

FEES:

* NR=non-resident. Each player not living in the District must pay an additional fee of **\$8.00. There will be a maximum of 5 non-residents charged.**

The season will begin on October 5 and will run 7 weeks through November.

A percentage of your league and non-resident fees will be designated for improvements to comply with the American Disability Act, and to pay for the increased electrical rates for the field lights & more.

Priority for filling the spots in the league will be on a first received, first placed basis. No registration packets will be accepted after **August 20**. **There are no refunds once a team is placed in a league.** If league(s) are cancelled money will be refunded.

ROSTERS:

Be sure all information is completed on the roster including each players name, address, phone number, drivers license number and signature. **If information is left out or your check bounces, the packet will be declared incomplete.**

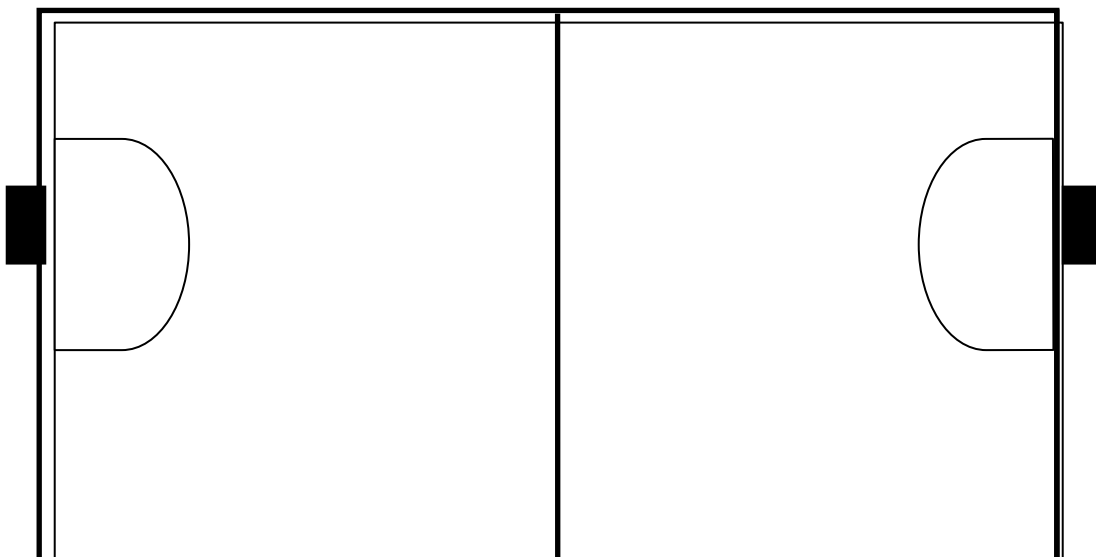
Roster additions and deletions must be made before 5:00 pm, Monday through Friday, prior to your game. This must be done in person at the Administrative Office or by mail with the League's "Add/Drop Form" (field staff will not handle any additions or deletions). An added player may not use a dropped player's non-resident fee after **October 5**. Teams may carry a maximum of ten (10) players on their roster.

ABRIDGED LIST OF RULES:

The Pleasant Hill Recreation & Park District Adult Soccer League will follow the International Federation of Football (F.I.F.A.) rules with some of the following exceptions:

1. Five (5) players per side (minimum of three (3) to start and continue).
2. No goalkeepers.
3. Unlimited substitutions.
4. Thirty (30) minute halves.
5. No tackling from behind
6. No sliding tackles or slides in an attempt to play the ball, whether touching an opponent or not. Players must remain on their feet at all times.

Field Diagram (Not to scale). Fields will be 50 yards long and 32 yards wide.



7. No players allowed to stand within eighteen (18) foot goal arc.
8. No throw-ins (kick-in from sideline, ball must be touching the line).
9. No off-side rule.
10. A goal can only be scored from inside the attacking half of the field.
11. A penalty shot will be awarded for any penalty foul committed inside the attacking half of the field (kick will be taken from the center line into an empty goal).
12. The league will provide one official for each game this season.
13. Referee will have the authority to suspend or eject a player from the game for any reason.
14. Suspended and or ejected players may be substituted.
15. Metal spikes, screw in spikes and rubber cleats are NOT permitted. SHORT rubber soccer "turf shoes" are highly recommended.

Other pertinent rules, regulations and information will be discussed and handed out in a pamphlet at the Annual Team Representatives Meeting to be held **Tuesday, September 21, 7:15 pm, at the Pleasant Hill Recreation & Park District Administration Office, 147 Gregory Lane, Pleasant Hill. All NEW teams are required to attend.(SEE ATTACHED FLYER)**

LEAGUE INFORMATION:

The Fall Season will consist of a seven (7) game schedule, no playoffs. All games will be officiated by one official.
