## ADULT SOCCER LEAGUE— 2012 SPRING SEASON

The games are played on smaller fields with smaller goals and no goalies. Smaller teams allow more games and players per hour to use the field, and make it easier to put together teams. It also allows all players to touch the ball more often. **The season will begin on March 20 and will run through June.**

\* *NR=Non-Resident. Each player not living in the PH District must pay an additional fee of \$8.00. There will be a maximum of 5 non-residents charged.*

A percentage of your league and non-resident fees will be designated for improvements to comply with the American Disability Act, and to pay for the increased electrical rates for the field lights & more.

**Registration will not be accepted without payment.** Priority for filling the spots in the league will be on a first received, first placed basis. No registration packets will be accepted after **March 9**. There are no refunds once a team is placed in a league. If league(s) are cancelled money will be refunded.

Returning teams are those that participated in one of our 2011 Fall, Summer or Spring Soccer Seasons with a minimum of 51% of the former team's roster. Teams that do not meet those requirements will be processed as new teams.

### ROSTERS/ROSTER ADDITIONS:

Be sure all information is complete on your team roster. If information is left out or your check bounces, the packet will be declared incomplete.

Roster changes must be received before 5:00 pm, Monday through Friday, at the District Office prior to your game using the League's "Add/Drop Form" (field staff do not handle any additions

or deletions). An added player may not use a dropped player's non-resident fee after **March 20**. Teams may carry a minimum of 5 and a maximum of fourteen (14) players on their roster.

### **ABRIDGED LIST OF RULES:**

The Pleasant Hill Recreation & Park District Adult Soccer League will follow the International Federation of Football (F.I.F.A.) rules with some of the following exceptions:

1. Five (5) players per side (minimum of three (3) to start and continue).
2. No goalkeepers.
3. Unlimited substitutions.
4. Thirty (30) minute halves.
5. No tackling from behind
6. No sliding tackles or slides in an attempt to play the ball, whether touching an opponent or not. Players must remain on their feet at all times.
7. No players are allowed to stand within eighteen (18) foot goal arc.
8. No throw-ins (kick-in from sideline, ball must be touching the line)
9. No off-side rule.
10. A goal can only be scored from inside the attacking half of the field.
11. A penalty shot will be awarded for any penalty foul committed inside the attacking half of the field (kick will be taken from the center line into an empty goal).
12. The league will provide one official for each game this season.
13. Referee will have the authority to suspend or eject a player from the game for any reason.
14. Suspended and or ejected players may be substituted.
15. Metal spikes, screw in spikes and rubber cleats are NOT permitted. SHORT rubber soccer "turf shoes" are highly recommended.

Other pertinent rules, regulations and information will be discussed and handed out in a pamphlet at the Annual Team Representatives Meeting to be held **Tuesday, March 13, 7:15 pm, at the Veterans of Foreign Wars Building, 1919 Wendell Lane, Pleasant Hill, located next to the Old School House.
